## ITEM 5. AMENDMENTS TO THE 2020-2022 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AND 2045 REGIONAL TRANSPORTATION PLAN (RTP)

Mr. Adam Beckom, H-GAC, provided a briefing on the Amendments to the 2019-2022 (TIP) and 2045 (RTP) as recommended by the Technical Advisory Committee and for Transportation Policy Council approval of Resolution 2020-19 for TIP Amendments and Resolution 2020-20 for Transportation Development Credits (TDCs)

MPOID 18004	Increase the federal STBG (Surface Transportation Block Grant) funding by \$153,000 on the Houston-Galveston Area Council Regional Planning Studies Bundle#1 to cover additional planning and administrative costs. Increasing the funding request resulted in the need of an additional 30,600 Transportation Development Credits (TDC).
MPOID	Increase the federal STBG (Surface Transportation Block Grant) funding by
16354	\$350,000 on the Houston-Galveston Area Council Regional Planning Studies Bundle#2. To match the increase in federal funding an additional 150,000 in TDCs is also being requested.

## ITEM 6. REVIEW AND DISCUSSION ON THE CITY OF HOUSTON'S LETTER CONCERNING THE NORTH HOUSTON HIGHWAY IMPROVEMENT PROGRAM (NHHIP)

Ms. Jennifer Ostlind, City of Houston, provided a presentation regarding The North Houston Highway Improvement Project (NHHIP) and briefed The Council on a letter dated May 12, 2020 by Mayor Sylvester Turner to Commissioner Laura Ryan, TxDOT.

Ms. Ostlind presented the City of Houston's recommendations to the Texas Department of Transportation:

- Mayor Turner expresses the City's support for funding contained in the Draft 2021-24
   Transportation Improvement Program for Segment 3 (around downtown Houston) with a number of specific recommendations the City desires to have further evaluated and incorporated into the final design of this segment.
- In Segments 1 and 2 (from Beltway 8 North to I-10), the City urges TxDOT to examine an alternative design concept which would remain largely within existing right of way so as to minimize the potential loss of housing and businesses.
- Recognizing the need to accommodate freight to and from our region, the City requests TxDOT, H-GAC and others examine ways to accommodate growing freight demand as part of a regional strategy across all modes. This strategy should examine the capacity to move freight by truck and rail as well as management strategies to effectively maximize use existing freight capacity.
- The City of Houston also identifies its desire for a collaborative examination of opportunities to reduce flood risk along the corridor and adjacent communities, restore and improve neighborhood connectivity, improve and create new parks and trails and complement and accelerate plans for two way bus rapid transit in the I-45N and connecting freeway corridors.

## DEVELOPING A MEMORANDUM OF UNDERSTANDING FOR THE FUTURE COORDINATION ON THE NORTH HOUSTON HIGHWAY IMPROVEMENT PROJECT (NHHIP)

#### **Background**

The North Houston Highway Improvement Project includes reconstruction and expansion of Interstate 45 North from US-59/I-69 at Spur 527 to Beltway 8 North. Known as the North Houston Highway Improvement Project (NHHIP), this investment jwould be one of the region's largest infrastructure projects in a generation.

This corridor no longer meets the travel needs of our region. This section of I-45 North contians some of the region's oldest pavements and bridge structures, many of which no longer meet current safety design standards. The facility does not provide adequate drainage, safe access to and from the mainlanes and adjacent frontage roads, does not support express transit to suburban job opportunities and is one of the State's most congested roadways.

In response to these many issues, the Texas Department of Transportation (TxDOT) developed the NHHIP. In its Draft Environmental Impact Statement,, TxDOT identified both potentially significant benefits for users of the I-45 North Corrdor and the greater Houston Galveston area; however the DEIS also outlines significant adverse impacts to residences, businesses, parks and other institutions along the corridor where additional right of way is needed.

The City of Houston embarked on an extensive public engagement process through which it developed a number of recommendations as expressed in Mayor Turner's June 9, 2020 letter to Texas Transportation Commission Member Lara Ryan (reviewed at our May TPC meeting). Harris County Commissioners's Court passed a resolution on July 9<sup>th</sup>, 2020 stating its upport for the recommendations made by Mayor Turner including additional specific requests concerning potential impacts to streets providing access to the downtown couthouse complex.

TxDOT has continued to actively engage with local governments, transportation agencies, businesses and residents to explore opportunities to address the projects potential adverse impacts. The scope and duration of work needed to address the issues (and opportunities) identified by the City of Houston Harris County, the Meropolitan Transit Authority and businesses and residents in the corridor will require a framework for the investigation of design alternatives, coordination with other agencies and support for ongoing public participation.

The investigation of design alternatives identified or sought by local governments, residents and other stakeholders will be lead by TxDOT and should include collaborative, muti-agency engagement that will support continued public participation and future funding decisions regarding the North Houston Highway Improvement Project.

#### **Current Situation**

The Transportation Advisory Committee (TAC) met on June 17<sup>th</sup> to consider a recommendation to the Transportation Policy Council concerning approval of the Draft 2021-2024 Transportation Improvement Program.

After significant discussion, the TAC recommends TPC approval of the draft 2021-2024 Transportation Improvement program with comments, which include:

- The City of Houston lead an extensive public engagement process through which it identifies clear project goals for the North Houston Highway Improvement Project (NHHIP), as identified in Mayor Turner's May 12, 2020 letter to Texas Transportation Commission Member Laura Ryan (and reviewed at H-GAC's May TPC meeting), as well as confirmed in Texas Transportation Commission Member Laura Ryan's May 20, 2020 letter to Mayor Turner, Harris County Commissioner Court's Resolution of June 9, 2020, and consistent with METRO's MetroNext Plan. TAC recommends TxDOT, TPC and other key agencies state their concurrence to work with all agencies involved to look at project alternatives to address issues brought out in the public engagement process.
- TxDOT should outline in writing it's plan to eliminate or further mitigate adverse impacts of the project and, where limited by its statutory authority or funding eligibility, work with other private and public partners to achieve the desired project goals detailed in the City of Houston Mayor Turner's letter.
- Many issues and recommendations to meet those goals, as expressed in Mayor Turner's June 12, 2020 letter to Texas Transportation Commission Member Lara Ryan (and reviewed at our May TPC meeting) are as yet unresolved. TAC recommends that TxDOT describe its process and timeline for resolution of these identified issues.
- TxDOT should describe to what extent implementation of Segment 3 as described may constrain alternatives which have been recommended in Mayor Turner's letter for Segments 2 and 1.
- Define in writing TxDOT's commitment to on-going public participation and publicly share its engagement goals and progress in its continued development of the NHHIP.
- Provide regular briefings to TAC and TPC by TxDOT on their progress toward resolution of the issues and recommedations contained in Mayor Turner's letter, the Harris County Resolution and other commenters.
- TxDOT should describe its plans for remediation of lost housing and businesses, including a description of its relocation assistance plans and support for the restoration of affordable housing.
- TxDOT should develop a financial plan to ensure that amenities such as bicyclepedestrian connections, parks, and aesthetic elements are supported and to eliminate any risk that such project investments are not implemented due to higher than expected project costs overall or a change in funding sources.
- TxDOT should provide the TAC and TPC regular updates on the alternatives under consideration and the impacts the alternatives have on freight, transit, air quality, travel times, pedestrians, bicyclist, housing, and businesses.

#### **Action Requested**

Request for approval for developing a Memorandum of Understanding between Texas Department of Transportation, H-GAC's Transportation Policy Council, City of Houston, Harris County, and Metropolitan Transit Authority of Harris County for future coordination on the North Houston Highway Improvement Project.



## Table - Other comments made by TAC members during TAC meeting in June or received in writing after the meeting, but not included in TAC recommendation and voting at the meeting:

- TxDOT should commence a comprehensive social impact assessment for residents that will be displaced in all segments of the project prioritizting Segment 3.
- TxDOT should outline in writing its plan to eliminate or mitigate adverse impacts of the project and, where limited by its statutory authority or funding eligibility, work with other private and public partners to achieve the desired project goals that have been identified through the public engagement process including recommendations that emerge from the social impact assessment.
- The NHHIP be removed from the TIP for a separate vote. The vote should not take place until a comprehensive plan has been developed that aims to treat the people that TxDOT intends to displace with dignity and respect. In the event that a vote moves forward, a resolution/MOU should be drafted and signed by all parties to include a mechanism through which the TPC will not continue to advance funding for the project if TxDOT fails to adhere to its written commitments in the resolution or MOU.
- Recommendation to TPC for approval of a resolution based on the above TAC comments and recommendations below:

Whereas, the Federal-Aid Highway Act of 1962 required, as a condition attached to federal transportation financial assistance, that transportation projects in urbanized areas of 50,000 or more in population be based on a continuing, comprehensive, urban transportation planning process undertaken cooperatively by the states and local governments. As such, MPOs have responsibility for planning, programming, and coordination of federal highway and transit investments in the urban areas which they cover; and

Whereas the H-GAC Transportation Policy Council has historically fostered and encouraged regional transportation planning that respects the needs of local communities when developing projects of regional significance; and

Whereas, the H-GAC Transportation Advisory Committee met on June 17<sup>th</sup> to consider a recommendation to the Transportation Policy Council concerning approval of the Draft 2021-2024 Transportation Improvement Program and facilitated a lengthy discussion about the North Houston Highway Improvement Project (NHHIP).

Now therefore, be it resolved that the Transportation Policy Council for the H-GAC directs TxDOT, the City of Houston, Harris County, and METRO to enter into a cooperative agreement for ongoing efforts on the NHHIP to address issues raised during the extensive public comment period and as described in the background to this resolution, including:

- Formalizing the parties' commitment to common goals for the NHHIP;
- Committing to a defined process for review of additional design alternatives for Segments 1 and 2, including reducing, or where possible eliminating, identified adverse impacts, and defining a timeline for this process; and

Committing to an ongoing process of public engagement and participation throughout the course of the project.

• The parties should delineate specific expectations linked to TXDOT's progress in addressing the concerns of residents, as outlined by the City of Houston, and TAC/TPC decisions to halt or withdraw funding should the project fail to address the very real concerns of residents – taxpayers – who live adjacent to the project.

## <u>APPROVAL OF THE 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM</u> (TIP)

#### **Background**

The Transportation Advisory Committee (TAC) met on June 7<sup>th</sup> to consider a recommendation to the Transportation Policy Council concerning approval of the Draft 2021-2024 Transportation Improvement Program.

#### **Current Situation**

The Draft 2021-2024 TIP contains projects which have been funded in the TIP timeframe by the TPC or through local sponsor action. This includes estimated amounts for future year federal transit funding as approved by designated recipients in consultation with other local transit providers.

Staff has also worked with sponsors to update locally-funded project information to ensure that projects that need to be listed in the TIP are updated and reflect latest available information. Based on feedback received from stakeholders and the public, staff has drafted a more concise and accessible document. The Draft 2021-2024 TIP is available for review on H-GAC's TIP website: http://www.h-gac.com/transportation-improvement-program/2021-2024.aspx.

The public comment period for the 2021-2024 Transportation Improvement Program began on February 28, 2020 and closed on April 15, 2020. H-GAC held two open house public meetings on the draft 2021-2024 TIP on March 5, 2020. The meetings were held in-person at H-GAC offices and were made available online as well. A total of 59 public comments were received. A summary of the comment topics is listed in the table below. After significant discussion, the TAC recommends TPC approval of the draft 2021-2024 Transportation Improvement program with comments, which include:

- The City of Houston lead an extensive public engagement process through which it identifies clear project goals for the North Houston Highway Improvement Project (NHHIP), as identified in Mayor Turner's May 12, 2020 letter to Texas Transportation Commission Member Laura Ryan (and reviewed at H-GAC's May TPC meeting), as well as confirmed in Texas Transportation Commission Member Laura Ryan's May 20, 2020 letter to Mayor Turner, Harris County Commissioner Court's Resolution of June 9, 2020, and consistent with METRO's MetroNext Plan. TAC recommends TxDOT, TPC and other key agencies state their concurrence to work with all agencies involved to look at project alternatives to address issues brought out in the public engagement process.
- TxDOT should outline in writing it's plan to eliminate or further mitigate adverse impacts of the project and, where limited by its statutory authority or funding eligibility, work with other private and public partners to achieve the desired project goals detailed in the City of Houston Mayor Turner's letter.
- Many issues and recommendations to meet those goals, as expressed in Mayor Turner's June 12, 2020 letter to Texas Transportation Commission Member Lara Ryan (and reviewed at our May TPC meeting) are as yet unresolved. TAC recommends that TxDOT describe its process and timeline for resolution of these identified issues.
- TxDOT should describe to what extent implementation of Segment 3 as described may constrain alternatives which have been recommended in Mayor Turner's letter for Segments 2 and 1.
- Define in writing TxDOT's commitment to on-going public participation and publicly share its engagement goals and progress in its continued development of the NHHIP.
- Provide regular briefings to TAC and TPC by TxDOT on their progress toward resolution of the issues and recommendations contained in Mayor Turner's letter, the Harris County Resolution and other commenters.
- TxDOT should describe its plans for remediation of lost housing and businesses, including a description of its relocation assistance plans and support for the restoration of affordable housing.
- TxDOT should develop a financial plan to ensure that amenities such as bicyclepedestrian connections, parks, and aesthetic elements are supported and to eliminate any
  risk that such project investments are not implemented due to higher than expected
  project costs overall or a change in funding sources.
- TxDOT should provide the TAC and TPC regular updates on the alternatives under consideration and the impacts the alternatives have on freight, transit, air quality, travel times, pedestrians, bicyclist, housing, and businesses.

## APPROVAL OF THE ADDITION OF TXDOT GAP PROJECTS, SHEPHERD DURHAM CORRIDOR PROJECT AND GARTH ROAD PROJECT TO THE 2021-2024 TIP

#### **Summary**

During the development of the 2021-2024 Transportation Improvement Program (TIP), H-GAC staff received requests to fund new projects. Normally the funding of new projects is considered during the call for projects process. Additionally, new projects may be selected for funding when presented with an opportunity to leverage funds allocated to the region for additional funding from other sources. The list of projects summarized below have been presented for consideration of funding.

- Program \$125.5M total Category 2 funds for the Texas Department of Transportation Houston District 'Gap Projects' in the 2021-2024 TIP. Below are comments from the Houston District regarding each project.
  - O SH 146 (Harris County) CSJ 0389-05-129/MPOID 13841 (S. of Spencer Hwy to Fairmont Pkwy Widen from four to six lanes to remove bottleneck). This project was not selected in a call for projects, but it is a gap piece/bottleneck project. The MPO did select 0389-05-087 (Fairmont Pkwy to Red Bluff). The 0389-05-129 project is adjacent to the project that was selected by the MPO and is currently a sub project to it for letting. Both projects show funding in the UTP using Cat 2.
  - O SH 146 (Galveston County) CSJ 0389-07-025/MPOID 467 (FM 519 to SL 197, Reconstruct RR overpass and Widen from two to four lanes, gap filler). This section of SH 146 is the last remaining two-lane section and has become a gap/bottleneck project. The project estimate is \$49.6M. Bridge Division has given a fixed amount of \$15M toward the project.
  - O US 90A (Fort Bend County) CSJ 0027-08-180/MPOID 16348 (US 90A at SH 99, Construct Grade Separation and Intersection Improvements). This project will construct a main lane bridge through the SH 99 intersection and provide needed intersection improvements. US 90A to the east was widened to six lanes and there is a project to the west of the intersection that has recently received funding through the last MPO call for projects that will also widen US 90A to six lanes, CSJ 0027-08-147. This bridge, if not funded, will become a gap/bottleneck project.
  - o FM 517 (Brazoria County) CSJ 1002-01-006/16320 (Galveston County Line to SH 35, Reconstruct and Widen from two to four lanes). This segment of FM 517 was not selected in the last MPO call for projects, but the piece of FM 517 in Galveston County was selected from IH 45 to Brazoria County Line (CSJs 0978-01-039 and 1002-02-016). If the Brazoria County piece of FM 517 is not funded this will become a gap/bottleneck project.

O SH 242 (Montgomery County) CSJ 3538-01-055/17146 (East of FM 1314 to West of FM 1485, Reconstruct and Widen from two to four lanes). The SH 242 corridor from Needham Drive to US 59/IH 69 was selected in the 2016 MPO Call for Projects under CSJs 3538-01-035 and 3538-01-036. CSJ 3538-01-035 (Needham Drive to FM 1314) was let 5/2019 and when we were months away from letting 3538-01-036 (East of FM 1314 to US 59/IH 69) we were having a permit issue near FM 1314 so it was decided not to delay the whole project and to split the project into two pieces. Limits were changed on CSJ 3538-01-036 to West of FM 1485 to US 59/IH 69 and project was let 8/2019. CSJ 3538-01-055 was created for the remaining limits and HGAC says there is no funding for project in the STIP. If project is not funded in STIP there will be a gap/bottleneck in the middle of the SH 242 corridor. Based on low bids from the previously let projects there is still \$11.2M (includes match) remaining from what was given to the SH 242 corridor in the 2015 Call for projects.

- Add \$20.73M (\$16.58M Federal and \$4.15M Local Match) in Surface Transportation Block Grant (Category 7) funding the City of Baytown's Garth Road extension and widening project to cover new resiliency standards design costs.
  - O Due to the recent release of new rainfall data and increase development the City of Baytown has had an increase in cost associated with this project. Through work with the Houston District the City is proposing to break their project into phases. The City is proposing to complete phases A and B with this request. Additional information is available in the letter from the City as attached.
  - As part of the amendment request the City is also proposing to move the federal funding awarded to the project during the 2015 Call for Projects for design and rightof-way (ROW) acquisition to the construction phase of the project. All design and ROW costs will be paid by the City of Baytown.
- Program \$50M (\$40M Federal and \$10M Local Match) in STBG (Category 7) funds to the City of Houston's Shepherd-Durham Corridor Improvement project into FY 2021 of the 2021-2024 TIP.
  - Phase 1 of the Shepherd Durham project received funding in the FY 2019 BUILD Discretionary grant program. In order to complete the project and to avoid higher costs in the future the City is requesting additional funds to complete Phase 2 as well.

Fiscal constraint analysis was done against the proposed projects in the draft 2021-2024 TIP document. The table below shows the available balances should these projects be awarded funding by the TPC. Please note that Category 2 funding is allocated over a 10-year timeframe. The total balance of Cat. 2 funding is \$2.9 Billion as identified in the FY 2020 Unified Transportation Program.

Dear Mr. Clark.

The Shepherd and Durham Major Investment Project (project) is a regionally significant project that addresses every one of our regional transportation priorities: safety, state of good repair, the movement of goods and people, economic competitiveness, and resiliency. The first phase of the project was recently funded through a FY19 BUILD award, an extremely competitive federal discretionary funding program. The City of Houston requests \$40M in H-GAC directed funding to leverage the federal BUILD funds and allow for the completion of the project in its entirety.

For background, in 2018, the project was submitted to the Houston-Galveston Area Council (H-GAC) Call for Projects in the Major Investment category. The submitted project proposed the reconstruction and improvement of the Shepherd and Durham corridor from IH-610 to IH-10. The staff recommendation and Transportation Policy Council (TPC) action yielded only one funding award within that category, for METRO's Inner Katy BRT.

In July 2019, the City of Houston, in partnership with the Memorial Heights Redevelopment Authority (Redevelopment Authority) applied for the project's funding through the FY19 United States Department of Transportation BUILD program. This program is the successor to the TIGER program and is one of the most competitive discretionary funding programs in the nation.

The application, due to BUILD funding limits, requested the maximum award of \$25M to be matched by \$25M in local funding for the northern half of the project, from IH-610 to W. 15<sup>th</sup> Street, referred to as Phase I. In November 2019, it was announced that the project was selected for funding in the full amount of \$25M. This award is the largest TIGER/BUILD grant the City of Houston has received to date, and the largest award within the State of Texas as a component of the FY19 program.

As a result of this award, the Redevelopment Authority has moved forward with design and environmental activities to prepare the entirety of the corridor for construction (both the funded project limits from IH-610 to W. 15<sup>th</sup> Street as well as the currently unfunded "southern" project limits from W. 15<sup>th</sup> St. to IH-10). This was made possible through H-GAC's decision to advance the entire project into the Regional Transportation Plan (RTP) and will create economies of scale associated with the coordination and administrative actions of the design and environmental approval process.

However, at this time, neither the City nor the Redevelopment Authority have the funds available to fund construction phase activities associated with the southern portion of the project, from approximately W. 15<sup>th</sup> Street to IH-10, known as Phase II. Failure to complete Phase II will leave a gap along the corridor related to safety, accessibility, drainage, and transit access. The transit access element is particularly important as the project will connect to a proposed terminal location for METRO's funded Inner Katy BRT. Furthermore, the entirety of the Shepherd/Durham corridor from IH-610 to US-59 has been reconstructed or is proposed to be reconstructed by various entities, except for the portion between W. 15<sup>th</sup> and IH-10, or Phase II of this project.

The original request to H-GAC in the 2018 Call for Projects was for \$65M in H-GAC funds to be matched by \$35M in Redevelopment Authority funds. With the \$25M BUILD funding in place, the project can move forward, in its entirety, with only a \$40M investment by H-GAC. This represents a unique opportunity to directly leverage federal discretionary infrastructure investment in the Houston-region, which will deliver a complete project.

H-GAC participation in this project would now result in the following funding framework, which includes an additional \$10M in local funds to match the additional H-GAC funding requested:

Total	\$100M	100%

The BUILD award validates the regional significance of this project, its benefits, and the bipartisan and broad-based political support it has received. Furthermore, the award and commensurate actions to complete design and environmental work demonstrate the project's readiness. The BUILD funding allocation reduces the total amount of H-GAC and other local resources required to deliver a holistic project, helping to stretch limited regional funds for our regional mobility needs. Finally, the scope of this project helps enhance the benefit of METRO's Inner Katy project and is in alignment with the work that Harris County is doing county-wide related to flood mitigation and transportation connectivity for all users and all modes.

It is for these reasons that the City of Houston requests H-GAC funding support for this regionally significant project.

In 2019, the Memorial Heights Redevelopment Authority, and the City of Houston were successful in their application for BUILD funding to support the reconstruction of Shepherd and Durham Drives between approximately IH-610 and W. 15<sup>th</sup> Street. The BUILD program, the successor to TIGER, is one of the most competitive United States Department of Transportation (USDOT) discretionary grant programs in the nation. In 2019, 666 applications were submitted requesting \$9.6B in funding. Only 55 projects and \$883M in funds were awarded. The Shepherd and Durham Major Investment project was one of only two projects selected within the State of Texas and received the maximum award amount of \$25M, matched by an additional \$25M of local funds.

The remaining project segment, or Phase 2, between approximately W. 15<sup>th</sup> and White Oak Bayou is presently unfunded. The fulfillment of this Phase will ultimately allow for cohesive multimodal connectivity and safety along the corridor, a fully improved linear drainage system, and provide an important connection to Houston METRO's Inner Katy BRT project. Unfortunately, local resources are not available to provide for the full \$50M cost of this Phase.

I am writing to express my support for the allocation of H-GAC resources towards Phase 2 of the Shepherd and Durham Major Investment project so that the full benefits of the holistic corridor improvement can be achieved. H-GAC funding dedicated to this Phase would best leverage USDOT investments towards this corridor and will demonstrate the Houston region's commitment to future large scale USDOT discretionary applications and resultant awards.

The BUILD award demonstrates that the USDOT recognizes the reconstruction of Shepherd and Durham are critical components of the transportation infrastructure for the City of Houston, the Houston-Galveston Region, and for the State of Texas; I fully support H-GAC doing the same.

The City of Baytown (City) applied to the Houston-Galveston Area Council (HGAC) for Transportation Improvement Program (TIP) funding in 2015 for improvements along the Garth Road corridor. Per the original application, the corridor is in a high-growth area where the heavy traffic from local and non-local drivers make this major corridor congested and unsafe. Options for other north/south corridors are limited for temporary and long-term relief of congestion and this is a critical regional project for transportation and drainage improvements.

<u>Original Scope:</u> The original intent of the project was to reduce the congestion and improve safety through widening the corridor and providing subsurface drainage improvements from IH-10 to Baker Road, construct raised medians and sidewalks along the entire corridor from IH-10 to SH 146, and provide dedicated right turn lanes as needed to reduce congestion and improve safety.

<u>Flood Resiliency:</u> Due to the recent extreme flood events, the City is also focused on providing a more flood resilient transportation route for access for the fire department located at the intersection of Garth Road and Cedar Bayou Lynchburg Road and the hospital located at the intersection of Garth Road and Baker Road. Therefore, the City tasked the design team to propose drainage infrastructure that would allow for at least one lane of traffic in both directions of to remain open during the 100-year storm.

<u>Preliminary Engineering Results:</u> The first step of the scope of work was to compile the Preliminary Engineering Report (PER) and have TxDOT review the schematic design of at least three improvement scenarios.

- <u>Drainage Infrastructure:</u> Based on the preliminary engineering design, the drainage improvements were found to be much more impactful to the project construction cost than anticipated with the original TIP funding application. Even without the increased flood resiliency discussed above, the need to convert the roadway from a cross section with a roadside ditch to an underground storm sewer system and curb and gutter roadway design was significantly more impactful along the corridor than previously anticipated. When factoring in the required detention to meet Harris County Flood Control District (HCFCD) standards, the drainage infrastructure construction costs were approximately six times greater than previously estimated (\$3.3M preproject construction cost estimate vs. \$20.7M preliminary engineering construction cost estimate).
- Roadway Reconstruction: The required storm sewer improvements will also require a complete
  reconstruction of Garth Road from IH-10 to just south of Baker Road instead of only the widening
  of the roadway as previously expected. This revision increases the project paving cost by
  approximately four times greater than the original requested amount (\$7.8M pre-project
  construction cost estimate vs. \$33.2M preliminary engineering construction cost estimate).
- Engineer's Opinion of Probable Construction Cost (EOPCC): Utilizing the information from the PER, it is estimated that the total project cost will increase from the Total \$21.81M requested in 2015 to \$79.28M in 2020 dollars.

<u>Proposed Project Phasing:</u> With this significant change in project scope and cost due to conditions in the field, the City is requesting an amendment to the scope of work approved in the original TIP application and is requesting additional funding to cover additional projected costs.

The City is proposing to break the project up into six proposed phases outlined in **Table 1** below. Based on the preliminary drainage and traffic engineering, the phasing of design projects will begin at IH-10 and progress to the south to the termination at SH 146.

Garth Road in the areas of Project A and B (between IH-10 and Archer Road) is rapidly developing, and the City requests that the scope of the TIP funded project be amended to include both Projects A and B to expedite this section of the roadway to attempt to complete the improvements in this area by the end of 2023. Based on the current available funding of \$17.50M, Project A alone could almost be fully funded with the current available TIP funds. However, the City would like to request additional funding from the TIP in the amount of \$20.73M (\$16.58 Federal | \$4.15 Local) such that both Projects A and B can be designed at the same time with construction anticipated to begin in 2021 and allowing construction to be complete by the 2023 goal. If Projects A and B are funded, the City will re-compete for additional TIP funding for Projects C through F.

<u>Engineering and Utility Relocation Costs:</u> The City is also proposing to pay for all engineering and utility relocation costs which would move all federal funds to the construction phase of the projects. The City will still match the 20% of the construction costs as well, meaning the City will be paying much greater than 20% of the project costs.

<u>Additional Considerations:</u> Two other activities that are in process that could impact the construction schedule are Property Acquisition and Environmental Clearance.

- <u>Property Acquisition:</u> As of the date of this memo, the required acreage of property to be acquired based on the proposed project phasing is shown in **Table 1** above. The City plans to wait to begin acquiring ROW until after the public hearing as part of the Environmental Clearance process. The City will begin acquiring the ROW with Project A and B and then work to the south. Information to note about property acquisition required for Project A and Project B:
  - Project A 0.25 acres of the 0.37 acres needed for Project A come from the mall development and the City has already begun negotiations with the mall redevelopment team.
  - Project B 2.23 acres of the 2.31 acres needed for Project B are required for the
    detention pond and a storm sewer easement along the south side of Archer Road to
    discharge to the proposed detention pond. After the public hearing, the City will begin to
    coordinate to acquire the necessary ROW.
- Environmental Clearance: Based on the preliminary analysis by the environmental engineer on the project, it is anticipated that the entirety of the Garth Road project (Projects A through F) will be filed together and will fall under a Categorical Exclusion (CE). As a key milestone of the environmental clearance process, the City and TxDOT are working towards a June 2020 public hearing. After the public hearing, the remainder of the process should take approximately a year to complete. Therefore, the environmental clearance process is anticipated to be finalized by the fall of 2021 and be complete prior to the bidding of Projects A and B (assuming Projects A and B begin design in the fall of 2020 and bid in the fall of 2021).

<u>Summary of Scope and Funding Revision Request:</u> The City of Baytown requests that the scope of work as previously defined in the 2015 TIP Application be revised to include the construction costs for the reconstruction of Garth Road from IH-10 to just south of Archer Road (defined as Projects A and B in Table 1 above). With this revised scope, the City also requests an increase in TIP funding from \$17.50M to \$38.23M to cover the estimated construction costs associated with both Projects A and B. As mentioned above, the City will pay for all engineering and utility relocation costs in addition to matching the 20% construction costs for Projects A and B.

The City intends to begin engineering design for Projects A and B immediately. The engineering designs for Projects C through F will follow as expeditiously as possible to continue to improve the traffic conditions and improve flood resiliency along the entire corridor as originally intended with the 2015 TIP application. If Projects A and B are funded with this revision, the City will re-compete for additional TIP funding for the construction costs of Projects C through F.

#### **Background**

#### **Current Situation**

#### REPORT ON TRANSPORTATION PLANNING ACTIVITIES

#### A. LONG RANGE PLANNING

#### 1. Sub-regional Planning Initiatives (SPI)

- Staff continue to work with consultants to finalize the Brazoria County Thoroughfare Plan. Minor revisions are being made to final products and the project is expected to be closed out next month.
- Staff continue to finalize the scope of work and budgets for Southeast Harris County Sub-Regional Plan and Liberty County Mobility Plan.
- Staff began initial work on the Montgomery County Precinct 2 Mobility Plan and are finalizing consultant scope and budget.

#### 2. Safety/Operations Planning

- Staff continues to develop H-GAC's first ever Regional Safety Campaign, set to launch later this year.
- Staff continues to work with City of Houston and Harris County on their Vision Zero initiatives
- Staff is working 2019 State of Safety report

#### 3. Freight Planning

- Staff are finalizing the scope of work for an update of the 2013 Regional Goods Movement Plan.
- Staff are coordinating a meeting of the Greater Houston Freight Committee to be held on June 18th at 1:00pm.

#### 4. Regional Incident Management

- Staff had a coordination meeting with the Houston Police Department and Harris County Sheriff Office on operations with the Tow and Go Program on May 5, 2020.
- Staff held a virtual Operations Task Force Meeting on May 7, 2020.
- Attended virtual TxDOT workshop on Houston Regional Planned Special Events on May 13.
- Staff held a virtual Traffic Incident Management Meeting on May 14, 2020.
- There were 2,541 "No Cost" Tows in the month of May; a 13% decrease when compared to May of 2019.
- Harris County released a RFP for their towing contracts for Tow and Go.
- SHRP2 Traffic Incident Management Training continues to be suspended because of COVID-19.
- Attended a virtual SH 288 Incident Management Coordination meeting with the Blue Transportation Group, Law Enforcement, Fire Departments and others.

#### 5. Environmental Planning

Staff has completed the "Quick User Guide" to the Eco-Logical tool which is designed to teach a new user how the tool works in several short steps. The guide is going through the final edits before publication. Staff have also begun talks with a contact in the Houston Independent School District (HISD) to discuss the prospect of students using the Eco-Logical tool within the environmental science or social studies curriculum. The initial talks have revealed an apparent interest in introducing the tool to the classroom.

#### 6. Resiliency Planning

Staff began development of a Low Impact Development study to examine how to cost-effectively integrate low impact development into transportation projects in the Houston area. Staff continue work on the Resilience & Durability Pilot project as part of the FHWA program to develop transportation-sector specific resiliency best practices and strategies across the country.

#### 7. Regional Transportation Plan (RTP)

A meeting of the Regional Transportation Plan Subcommittee was held on June 10. Staff presented a draft outline and schedule of the next RTP update, an update on the Congestion Management Plan, and an introduction to Performance Measures.

#### 8. Other Planning Activities

Staff continue to monitor regional travel impacts of COVID-19. Regional travel volumes are monitored through StreetLight data and transit ridership numbers are reported monthly from transit agencies within the region.

#### **B. SHORT RANGE PLANNING**

#### 1.Project Programming

- Staff has worked over the last month to finalize all revisions to the draft 2021-2024 TIP document. Additional information about the TIP will be presented at the June meeting for TPC action.
- Last month H-GAC staff processed 6 Administrative Amendments to the TIP and RTP.
- Discussions on the Transportation Development Credit (TDC) policy and possible new uses of the available credits continued at the TIP Subcommittee. Efforts to update the current policy will continue over the next few months as staff continues to refine the policy at the subcommittee level before bringing recommendations to the TAC and TPC.

#### 2. Pedestrian and Bicyclist Planning

- Hired Susan Jaworski as the new Senior Planner over Ped/Bike Planning
- Held meeting with City of Houston and Houston Parks Board regarding use of mobile counters
- Developed guide for deploying mobile counters.
- Replaced batteries for permanent counters
- Meeting held for Federal Highway/Sugarland Multimodal Connectivity grant.

#### 3. Transit Planning

- A grant application was submitted to TxDOT for the Regionally Coordinated Transportation Plan (RCTP) for 2022-2026. Response from TxDOT should be forthcoming in June 2020 on the application soon. Planning activities on the RCTP are expected to begin September 1, 2020.
- An updated Congestion Management Process in partnership with Project Development, Safety, GIS & Modeling and Regional Planning is proceeding
- A draft TAM plan has been completed. Updated analysis and targets will be reported to relevant subcommittees and for public comment between now and September 2020.
- Staff continues to conduct a monthly survey regarding the effects of the COVID-19 pandemic on regional transit providers. This survey will continue during the course of the pandemic.
- Staff continues to work with Texas Southern University on a final report detailing the performance and acceptance of an autonomous vehicle that operated on campus between June 2019 and February 2020.
- Coordination continues between H-GAC and METRO regarding the Regional Transit Seamless Fare System.
- Implementation of The Woodlands Township Energy Corridor Commuter service is delayed until at least January 2021 due to COVID 19. A meeting with the principals will be held to determine next steps.
- Development of Fort Bend County Transit service implementation for the Fort Bend County to Houston Central Business District route is delayed pending approval of a Federal Transit Administration Letter of No Prejudice (LONP).
- Staff is developing a scope and budget for a Transit Needs Assessment for the City of Pearland.
- Staff held a meeting with the City of Huntsville about transit interest.

#### 4. North Houston Communities Transportation Priorities Study

- Staff drafted AFA resolution request and background document for May Board approval. This is in preparation for a TxDOT AFA request for the North Houston Community Transportation Priorities Planning Study in June.
- Submitted AFA request to TxDOT. Staff continues the AFA process with TxDOT through June.
- Staff continues drafting the detailed Statement of Work, task timeline and budgets in preparation for procurements.
- Staff met with the City of Houston Planning Department regarding North Houston Community Transportation Priorities Plan Research continues on all existing studies related to segment 2 of the North Houston Highway Improvement project Staff attended community meetings related to the project.

#### C. TRANSPORTATION PUBLIC OUTREACH

#### 1. General Transportation Outreach

- Public outreach staff hosted a virtual Brown Bag webinar on June 15 in conjunction with Houston TranStar. The total number of attendees was 100.
- Public outreach assisted in the coordination and promotion of the Commute with Confidence webinar for employers returning to their worksites. Other cities are now beginning to use the Commute with Confidence resource as a model for their own.
- In addition, staff have been working to update information and materials related to the Mobility Report, and also prepare for the launch of the Zip Zone Map campaign, Tow and Go's expansion, and the upcoming transportation studies throughout the region.

#### 2. Commute Solutions

- Staff participated in Strategic Planning Meeting on May 4
- Staff participated in a variety of internal meetings and staff development trainings.
- Staff participated in weekly Vanpool Task Force Meetings with METRO STAR
- Staff created, prepared, and executed a regional Commute with Confidence Webinar with area transit agencies. 195 registered. Over 150 attended.

#### D. CLEAN VEHICLES/HEAVY DUTY DIESEL REPLACEMENT PROGRAMS PLANNING ACTIVITIES

#### 1. Clean Vehicles Program

- Staff continues to reach out and work with ISD's to replace older school buses
- Staff is working with several grant recipients to finalize contracts and complete invoicing.
- Staff continues to respond to incoming phone calls and email requests for program information.
- Staff continues to monitor grant recipient's usage of vehicles to assure grant requirements for vehicle use and mileage are met.
- Staff participated in a variety of internal and external meetings.

#### 2. Heavy Duty Diesel Replacement Program

- Staff continues to work with grant recipients to finalize contracts; ad complete invoicing
- Staff continues to respond to incoming phone calls and email requests for program information
- Staff continues to monitor grant recipient's usage of vehicles to assure grant requirements for vehicle use and mileage are met.
- Staff participated in a variety of internal and external meetings.

### E. GENERAL AIR QUALITY PLANNING ACTIVITIES

- Staff is continuing to develop of the annual Air Quality Initiatives report to cover regional air quality improvement programs administered in 2019 with the assistance of H-GAC.
- Staff has is continuing to develop required updates to the Congestion Mitigation and Air Quality Improvement (CMAQ) Program Total Emission Reduction Performance Measure.
   Tentative results were presented to the Transportation and Air Quality (TAQ) Subcommittee for discussion on April 16. Revisions are currently underway and it is anticipated that drafts will be available for public comment in July, then presented to the TAQ Subcommittee for approval in August.
- H-GAC staff is continuing to assist with regional efforts to support the Department of Energy (DOE) sponsored Houston-Galveston Clean Cities Coalition. Under the auspices of this program, staff works with regional fleets to foster economic, environmental, and energy security by working to advance affordable, domestic transportation fuels, energy efficient mobility systems, and other fuel-saving technologies and practices. Staff has developed a program of activities for 2020 and anticipates involvement with several new and novel types of events including: podcasts, webinars, and, potentially, alternative fuel site visits in the latter half of the year. The first webinar is scheduled for May 21st and will focus on funding availability to help interested fleets continue to make the transition to alternative fuels even in these difficult times.
- Staff has completed closeout activities for the now-completed DOE-sponsored Zero Emission Delivery Vehicle Demonstration Project. This project resulted in the deployment of 18 all-electric delivery vehicles at UPS locations within our region. Despite the conclusion of project activities, most of these vehicles will continue to operate on our region's roads.
- Staff is continuing to work to administer EPA-funded DERA grants to deploy all-electric yard tractors at local freight warehouses. Staff is currently working with IKEA and H-E-B to finalize the contracting process in order to move forward with vehicle purchases.

#### F. TRAVEL DEMAND FORECASTING

- Staff continues to provide travel demand modeling and GIS technical supports and
  assistances to support H-GAC's internal planning work and H-GAC's member agencies such
  as TXDOT for their various corridor and sub-areas transportation planning and studies and in
  support of 21 separate link analysis within 4 corridors for the Inner Katy assessment project.

- Staff continues to provide modeling support through the use of the REMI model for the analysis of the COVID-19 Impact, verify and convert SANDAG revenue model to our region for COVID-19 impact analysis, work on PM2 2020 update on bridge and pavement rating data analysis, the summary and mapping, the test of Regional COVID-19 economic impact in REMI, and coordinate a resilience project for Harris County Flood control district On-going

- Staff completed AIMSUN software training and continues to provide support effort towards the meso and micro modeling in AIMSUN for Montgomery County. On-going
- Staff continues to work with METRO and other regional providers staff to resolve some issues and concerns caused by the COVID-19 pandemic in the scope of services for the forthcoming 2020/2021 on-board transit survey. On-going
- Staff continues to work with City of Houston Aviation department to develop a MOU, scope of services, sample size, and timeline for regional commercial airport (IAH & Hobby) ground access count travel survey. On-going
- Staff continues working on the acquisition of the location-based software which lets user see how people are travelling within the eight-county region and understand how this may be changing throughout the day. On-going
- Staff continues to review INRIX speed data to look at speeds and travel times to determine the impact of the Tow and GO program. On-going
- Staff participated in the MARAMA's R Training (Parts 1-4), TxDOT research project "Assessing
  Ozone Impacts on Electric Vehicles adoption in Texas", training in conditional charts in excel, TRB
  webinar "Resources for State DOTs to consider GHG emissions and climate change in NEPA
  documents, analysis of daily PM2.5 monitors versus wind, Inputs for conformity (new folders and
  data)and TWG presentation on the impacts of COVID-19 on air quality in the HGB region
- Staff continues to assist with the North Houston Highway Improvement Project- Helping with task 2 data collection. Mapping existing recommended projects(RTP,TIP, Livable Centers, etc.), transit routes and stops, bike lanes, sidewalks, B-cycle locations., GTFS Feed- Creating GTFS feed for local transit agencies, Montgomery County PCT 2 mobility plan- Creating study area map, and FHWA MMNCP- Creating online interactive map for Ped/Bike study in Sugar Land.
- Staff continues to assist with the COH Tow & Go, the development of Python Scripts for Center-Lane miles, and Speeds Analysis before and during COVID pandemic

#### PERFORMANCE MEASURES UPDATE

#### **Background**

A performance-based transportation planning process is required by federal regulations in the development of the Transportation Improvement Program (TIP) and the Regional Transportation Plan (RTP). A component of performance-based planning requirements includes the formal adoption of performance measures targets in key areas.

The first set of federal Performance Measures targets were formally approved by the Transportation Policy Council in 2018 for the areas of:

- Safety
- Pavement and Bridge conditions
- System Performance (Reliability, Congestion and Air Quality)
- Transit Asset Management

Measuring and tracking the performance of the region's transportation system provides a strategic approach to evaluate the effectiveness of transportation investments and track progress toward achieving goals. #### **Current Situation**

The federal performance period extends from 2018 to 2022. In 2020, at the mid-point of the performance period, assessments and reporting are required. In order to measure progress, staff is analyzing the most recent data for the various performance areas. Staff is performing data analysis to verify data accuracy, measure progress towards the 2-year targets, consider adjusting the 4-year targets, and document this work in a report. Staff is collaborating with the Texas Transportation Institute, the Texas Department of Transportation (TxDOT) and local governments for the data review and analysis. Mid-point target assessments and reporting are due to TxDOT and the Federal Highway Administration on September 30, 2020.
